When you receive the payment upload notice from this Branch, you may make payments by using the following payment methods:

- I. Convenience Store Payment: In cases of overdue national taxes or local taxes, or overdue fuel taxes of cars/motorcycles or traffic fines less than NT\$20,000, etc., you may take the payment upload notice with the barcode printed below and make payments at the four convenience stores, Seven-Eleven, FamilyMart, Hi-Life, and OK, nationwide within the deadline, and shall mail or fax a photocopy of this notice together with a copy of the payment certificate stub to the managing section of this Branch to write off the arrears (phone the managing section to see if it is accepted after the fax is received) without having to appear in person at the time for appearance (for traffic fines, you shall pay the handling fees).
 - II. Post Office Payment: In cases of overdue fuel taxes of cars/motorcycles or traffic fines less than NT\$20,000, etc., you may take the payment upload notice with the barcode printed below and make payments at the post office within the deadline, and shall mail or fax a photocopy of this notice together with a copy of the payment certificate stub to the managing section of this Branch to write off the arrears (phone the managing section to see if it is accepted after the fax is received) without having to appear in person at the time for appearance.
 - III. Money Order Payment:
 - (1) Fill in the “domestic remittance” note and purchase a postal money order at the post office:
 1. Beneficiary: fill in “Name of Referring Authority”.
 2. Address: fill in and mail it to “Address of Referring Authority”.
 3. Telephone: fill in “Phone Number of Referring Authority”.
 4. Amount: fill in the “Total” sum of the amount payable on the front side of this notice.
 5. Type of Remittance: check “Money Order”.
 6. Handling fee of NT\$30 per money order.
 - (2) Purchase a money order and send the original copy of the money order together with a copy of this notice to the beneficiary (referring authority) by registered mail, and mail or fax the copy of this notice, the purchase certificate of the money order, and the copy of the registered mail receipt stub to this Branch to write off the arrears (phone the managing section to see if it is accepted after the fax is received) without having to appear in person at the time for appearance.
- ※ Please pay attention to the following matters when purchasing and mailing postal money orders:
1. If you receive multiple notifications from different referring authorities, you should make each referring authority the payee and issue multiple money orders and send them to each referring authority separately instead of issuing one money order in total by yourself, otherwise the arrears will not be written off.
 2. If you receive multiple notices with the same execution case number, tax arrears year, and the same amount, you may pay only once, or phone the managing section for confirmation.
- IV. Handling Payments at this Branch: The person who is notified or his agent may take this notice to the Branch for payments or may use a credit card to make payments at this Branch.
- V. It is advised that you try your best to use Payment Methods I through III to make payments so as to speed up the settlement and save your precious time.
- ※ Prevent phone fraud, stop, watch, and listen without panic. This Branch will not take the initiative to additionally notify the public of the use of ATM to transfer or make payments for various cases. If you have any questions, you may inquire of the directory operator about or search the Branch phone number online for verification.
