Gold Coins for Integrity: Administrative Enforcement
Agency Taichung Branch Enters Campuses for Integrity
Promotion

On the 28th, the Administrative Enforcement Agency, Ministry of Justice Taichung Branch visited Tbulan Elementary School in Heping District, Taichung City to conduct a campus promotion aimed at promoting integrity and administrative enforcement. During the event, a short story was shared with the students to emphasize the importance of integrity and honesty. Additionally, the students participated in a game called "Quiz for Gold Coins", which provided a competitive auction experience. The children found the activity to be both interesting and enjoyable.

Taichung Branch Director Hsu Wan-Xiang of the Administrative Enforcement Agency has called for the implementation of a rural school outreach program this year, citing the insufficient educational resources available in these areas. In a recent event, Director Chen from the Political Affairs Office led the first activity to Tbulan Elementary School. The program's main theme was "The Integrity Story of Pai Po," which

featured a self-authored and self-illustrated book by the Administrative Enforcement Agency. The book narrates the tale of "Captain White Beard and Captain Black Beard. The book warns against the dangers of greed and dishonesty. In the book, the captain of a notorious black bearded ship learns a hard lesson about the dangers of greed and dishonesty. In his pursuit of fame and fortune, the captain makes a deal with a sea monster that ultimately leads to the sacrifice of the health of nearby villagers. Despite gaining a large sum of money, the captain faces sanctions and ultimately loses everything. The film serves as a cautionary tale, calling on viewers to prioritize integrity and honesty over personal gain. In particular, the film emphasizes the importance of developing a strong character of law and discipline from a young age. The captain's downfall serves as a warning to all, and the film concludes with a call to action for school children to "stay away from drugs" and prioritize good character development. Don't miss this powerful new film, which offers a timely reminder of the importance of honesty and integrity in all aspects of life.

This event was designed as a "Quiz for Gold Coins" game, in contrast to the previous promotional methods. In addition to "The Integrity Story of Pai Po," Director Chen used a suspected bullying incident at a high school campus in Taichung City and a number of previous cases of transnational fraud to promote the concepts of anti-strike, friendly campus, information security, and anti-fraud to the students, and asked them pertinent questions to encourage them to answer the questions in order to receive "gold coins."

The Administrative Enforcement Agency (AEA) is a division responsible for the enforcement of monetary obligations under public law. Director Chen acted as the auctioneer and auctioned off Taichung's specially prepared promotional items for the students, who used the coins they received for correctly answering the questions to bid against one another, bringing the promotional activity to its conclusion.
