

In 2025, Taichung Branch,Administrative Enforcement Agency received a total of 1,166,751 cases · 10,724 less than 2024. In terms of nature, 116,155 (10.0%) were finance and tax cases, 80,144 (6.9%) were health insurance cases, 506,968 (43.5%) were cases about fines, and 463,484 (39.7%) were cases about fees.
