


In 2025, Taichung Branch,Administrative Enforcement Agency collected NT\$2,642.246 million, NT\$245.38 million more than 2024. Of the total amount, the collection from finance and tax cases accounted NT\$1,117.46 million, or 42.3%. It was followed by NT\$631.40 million from health insurance cases. NT\$245.18 million from fine cases, and NT\$648.21 million from fee cases. The last three accounted for 23.9%, 9.3%, 24.5%, respectively.
